MEMORANDUM OF UNDERSTANDING

This Memorandum Of Understanding entered into on 13th JULY, 2015 BETWEEN **M/S GODREJ INDUSTRIES LTD** hereinafter referred to as 'the Delivery Partner' of the ONE PART and **BGPS' Mumbai college Arts, Commerce & Science** situated at wadala (E) hereinafter referred to as 'the Resource Partner', of the OTHER PART.

WHEREAS the Delivery partner has represented to the Resource Partner that they are certified as authorized to deal in educational products, training session and workshops.

AND WHEREAS the Delivery Partner has offered to enrol the students of the Resource partner, for Certification Programmes, where in for the support of the same workshop would be organized for free.


The parties hereto have discussed the details of the offer submitted by the Delivery Partner and are desirous of recording the terms of the arrangement in writing.

IT IS HEREBY AGREED TO BY AND BETWEEN THE PARTIES HERE TO AS UNDER:

1. The Delivery Partner has agreed to enrol the students of the Resource Partner for the Certification Programme.
2. The Delivery Partner will register the enrolled students for the relevant **Training on Road Safety program**
3. The Delivery Partner will provide workshop for support of certification.
4. The Training will be of a **minimum Of 10 hrs morning**.
5. The free training/workshop will be provided in the premises of the Resource Partner.
6. The Delivery Partner shall start the bundled free training of the enrolled students as per the availability and time slot provided by college and students and will facilitate the students.
7. The delivery partner shall allow the students of the resource partner for visit of the industry.
8. The delivery partner shall allow for Internships for students of resource partner.
9. The tenure of the contract would be for a period of four year i.e. from 2015 to 2019, the same would be subsequently renewed based on mutual consent.
10. The Resource partner will allow the Delivery partner to use the Computers and related infrastructure for the purpose of the training.

11. The resource partner will arrange for the availability of required Computer of desired configuration, to enable the Delivery Partner to conduct the said programme.
12. The Delivery partner will be allowed by the Resource Partner to display their publicity material in the Campus of the Resource Partner. However, the nature and place of display will be subject to the approval of the Resource Partner.
13. Resource Partner cannot hire any resource of the Delivery Partner either directly or indirectly for any full time or part time assignment without the permission of the Delivery Partner for a minimum period of one year that also after the contract with the college has expired.
14. Once the agreement is signed between Resource Partner & Delivery Partner, the same cannot be terminated for at least one year from the signing of agreement.
